



This qualification reflects the role of support workers who complete specialised tasks and functions in aged services; either in residential, home or community-based environments. Workers will take responsibility for their own outputs within defined organisation guidelines and maintain quality service through the development, facilitation and review of individualised service planning and delivery. Workers may be required to demonstrate leadership and have limited responsibility for the organization and the quantity and quality of outputs of others within limited parameters.

## FACE-TO-FACE SCHEDULE

This course is scheduled as:

- 74 weeks | 20 hours per week | 6 terms | 10 week terms (plus term breaks)

Homework, reading and assessment tasks are completed between each workshop. We recommend that learners set aside between 5–7 hours per week for homework, reading and assessment tasks.

## PATHWAYS

Students can enter directly into the CHC43015 Certificate IV in Ageing Support without prior qualifications. Students may choose to enrol into a double qualification with CHC33021 Certificate III in Individual Support or CHC52021 Diploma of Community Services.

Applicants who have successfully completed CHC33021 Certificate III in Individual Support (ageing specialisation) may be eligible for up to 9 credits towards the CHC43015 Certificate IV in Ageing Support.
